

**RULES AND REGULATIONS OF
" SKILL DEVELOPMENT SOCIETY"**

1. **MEMBERSHIP:**

The membership of the society is open to any person or persons Who has attained the age of majority and fulfill the terms and Conditions of the society without discrimination of Religion,cast,colour or creed but subject to the approval of executive body.If the membership is refused to a person,the reason for the refusal shall be communicated to the person concerned.

2. **SUBSCRIPTION:**

Admission fee shall be 1100/- at the time of Admission and subscription shall be 100/- per annum.

3. **TERMINATION OF MEMBERSHIP:**

The executive body shall have the power to terminate the member from the society on the following grounds:

- (i) On his/her death
- (ii) Non payment of Subscription continuously for three weeks from the date due.
- (iii) On his/her written resignation.
- (iv) He/She has not attended three consecutive meetings of executive body without any intimation.

Note: The reasons of termination to the member concerned shall be communicated.

4. **APPEALS:**

All the appeals should be preferred to the General body of the society. The decision of the General body shall be final. The reason for rejection shall be communicated to the member concerned. In case the member expelled by the governing body, the same can be re-admitted in case of termination of membership is due to reason stated in section 3(ii) of rules and regulations of the society, provided the member concerned pays up to date dues. The decision of the General Body shall be final.

6. **BANK ACCOUNT:**

The Bank account of the society shall be opened in any nationalized/RBI approved Bank in Delhi or Within India and its account shall be operated with joint signature of any two in Chairmen, Secretary and Treasurer Or single signature of any one person authorized by Executive body for special causes.

7. **GENERAL BODY:**

All the members of the society shall constitute the Executive body.

8. FUNCTIONS OF THE GENERAL BODY:-

- (1) To Consider any business brought by the Executive body.
- (2) There shall be an annual meeting of the general body in the month of March every year.
- (3) Not less than 15 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date ,time ,place and the quorum shall be 2/3rd.

9. SOURCE OF INCOME:

10. EXECUTIVE BODY:

The executive body's strength shall be not less than 8 and more than 11. The members of the executive body shall hold the office for Three years. The meeting of the executive body shall be held as and when necessary for which 3 days clear notice shall be required and the quorum shall be 2/3rd.

11. ELECTION AND QUORUM:

The general body in its annual meeting will elect its President/Chairmen and all the office bearers and members after Three year by secret ballot papers. The members of Executive body shall be elected with quorum of 2/3rd.

12. FUNCTIONS OF THE EXECUTIVE BODY:

14. REGISTER OF MEMBERS.

- (ii) The date of birth of the member.
- (iii) Occupation of the member.
- (iv) Date of Executive body meeting by which the decision regarding the membership was taken.

15. RIGHTS AND PREVIDLEDGES OF THE MEMBERS:

All and every member of the society:

- (i) Shall have one vote at every meeting.
- (ii) Shall be entitled to participate in the meetings,religious/ Cultural functions and other lawfull gathering called/ Arranged by the society.
